Major Items of Work:

The replacing the existing 6" diameter water main located on Marshall Avenue from Butterfield Road to St. Charles Road to by installing 8" ductile iron pipe and fittings. New valves, valve vaults and fire hydrant assemblies will be installed. Copper water service lines will be installed replacing the existing lead service lines. Approximately 1,100 linear feet of eight-inch (8") ductile iron water main will be installed with new valves, valve vaults, and water service connections to feed residences, restoration of immediate pavement areas, intermittent curb and gutter replacement, concrete sidewalks, driveways, and landscape restoration.
